In 2016, the Board of the Western Research Institute Limited (WRI) embarked on an ambitious new Strategy to strengthen WRI's role as a leading contributor to research and policy on inland development.

When we talk about rural and regional Australia we are not talking about one place, but a multitude of distinctive communities with different needs and aspirations.

This is often lost in public policy discussions about regional development.

As a result, WRI believes it continues to have a critical role to play in contributing to discussions that ensures that public policy is responsive to the particular aspirations, opportunities and needs of inland communities.

Since its inception in 1999, WRI has staked out its place as the provider of high quality research and strategic advice in western NSW.

The foundation for our success has been our ability to deliver well-researched, credible, objective and independent economic advice to our stakeholders. What makes us different, however, is that we understand the value and importance of local knowledge and expertise in translating the ambitions of our communities into sound economic plans.

Our 2016-20 Strategy focusses on the sustainability and growth of WRI, so that we can ensure that inland communities continue to have access to high quality advice that is informed by a rigorous understanding of the circumstances, needs and opportunities of our communities.

This report sets out our performance in meeting our ambitions in 2016. With your support, advice and insights, we have worked hard to ensure our services and contributions are more attuned and responsive to your needs.

This report also shows how investing in local knowledge and expertise not only delivers better outcomes, but also delivers more economic activity and growth back to our communities.



In 2016, we returned more than 90% of our surplus back to our communities through the establishment of the public-purpose Inland Research Fund.

We committed more than 8% of our total operating budget to support major conferences in our regions, conduct innovation forums for local businesses, share our knowledge through public commentary and support local events.

And of course, we employ all our staff in the regions to ensure that we keep our resources local, and build the regional talent pool for the future.

In 2016, we welcomed new Directors to the Board to help us to implement our new strategic direction, and grow our networks to influence policy on inland economic development. We also farewelled three outstanding regional leaders who have helped guide and direct WRI over many years – Michael Milston, Ian Davison and Ian Rogan.

Board Changes

During 2016 WRI undertook a strategic governance review to assist the Board in determining the skills, qualifications and experience to drive the new strategic plan, including the development of a Board Succession Plan. Following this review, the Board farewelled Michael Milston, Ian Davison and Ian Rogan and welcomed two new Directors; Andrew Everett and Jo-Anne Strader. WRI has greatly benefited from the outstanding contribution of the outgoing Directors and thanks them for their dedication and service.

Happy Customers

We have been working hard to make sure that we meet and exceed our customers' expectations. In 2016, we aimed to have a Net Promoter Score (that is the difference between the percentage of customers who will actively promote our work, minus the number who are neutral) of at least 80%.

In 2016 our Net Promoter Score increased from 54% to 80%.

In 2016 we delivered a \$54,643 surplus - a 316% improvement on 2015.

Return To Our Communities

In 2016, we committed to continuing to invest in the growth of our communities by buying from regional businesses, contributing to public discourse and funding public research.

In 2016 we returned 91.4% of our surplus (\$50,000) to create the Inland Research Fund (IRF) to support public good research into the needs of inland communities, and the opportunities for economic and employment growth.

We invested a further \$45,000 (8% of our operational budget) into regional development activities during the year, including:

- sponsorship of the Australian Regional Development Conference, partnership with the Illawarra Regional Information Service, the Bathurst Women's Network and the Bathurst Business Chamber;
- providing thought leadership and insights at key economic development forums, including hosting an Innovation Forum as part of our Insight Series, presenting to the Economic Development Officer's Network, chairing a panel at the Australian Regional Development Conference and leading media commentary on the inland rail at the Central West Business Summit;
- publication of research reports, particularly an Aged Care Skills Hotspot report with Verto; and
- a range of media commentary and other engagement activities.

Regional Citizenship

Investing in local knowledge and expertise not only delivers better outcomes, but also delivers more economic activity and growth back to our communities.

By using our regionally based service, every \$1 dollar spent by our clients with WRI results in a multiplier expansion of 2.2 in regional NSW.



WRI is committed to ensuring the growth of regional economies through our procurement practices, actively seeking to use regional businesses wherever possible.

Through our regional expenditure, WRI helped create:

- \$1.277 million in output
- \$72,100 in gross regional product
- \$432,000 in household income
- 6.4 full-time equivalent jobs for the regional NSW economy



In December 2016 WRI established the Inland Research Fund. Its mission is to build effective collaborations, deliver objective evidence and increase our policy influence to support improved decision making and investment for the development of inland Australia.

WRI recognises that there is a great deal of research on rural and regional communities in general, but this often fails to differentiate between the experiences and needs of coastal, city and inland communities, or different communities within inland areas.

The Inland Research Fund was established with an initial \$50,000 in seed funding, and will be expanded over the coming years through surpluses generated from WRI's regional activities and through contributions and grants.

Our goal is to give inland Australia a stronger voice about its future in public policy development.

We are very proud to have the opportunity to give back to the communities and regions that support our work through the establishment of the Inland Research Fund.
